SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. A proposed plan was submitted to administration for comment and approval based on needs established upon review of data from current health guidelines from Federal, State and Local Health Agencies, Board input regarding budgetary consideration to provide principals and other school leaders with the resources necessary to address the needs of the school, and consultation with parents and staff members. Once the proposed plan was approved by administration it was put out for public comment. We received no comments from the public.

We have been using Zoom Meetings for all school family meetings, since March of 2020. We informed families of the proposed plans at "Town Halls" conducted on 6/23/21, 8/31/21, 9/13,15, 21 & 23/21. This provided them the opportunity to provide input and feedback. All families, including families with students that fall into the following student sub-groups- students with disabilities, English Language Learners, low-income students, homeless students, students in foster care, migrant students, incarcerated students- are provided the opportunity to participate.

All-staff meetings provided our staff with the same opportunity. These were conducted in March, April, June & September 2021. We also conducted periodic surveys to consult with both school families and staff.

Throughout the implementation of the plan, we will continue to use Zoom meetings, all-staff meetings and surveys to consult with school families (including families with students that fall into the following student sub-groups- students with disabilities, English Language Learners, low-income students, homeless students, students in foster care, migrant students, incarcerated students) and staff about any necessary revisions to the plan and accept feedback and comments.

Opportunity Charter School has allocated a portion of the ARP ESSER Funds to implement prevention and mitigation strategies that go above and beyond those that have been directed by the CDC, State and Local Health authorities. We have contracted with C-19 Safety First to COVID test 25% of our staff and students weekly. The mission of C-19 Safety First is to drive more equitable access to education, dynamic work opportunities, and positive health and life outcomes. We have also leased additional space in order to meet the current mandates for Social Distancing of students and staff members.

Opportunity Charter School has in place a three tiered intervention program that is used to support students with any academic deficits they have in Math and ELA. In order to aggressively address the further deficits that have arisen from remote learning we have hired additional teaching staff and also used the ARP ESSER Funds to maintain existing teaching positions to maximize in-person instruction time and have smaller group instruction. This enables us to target exactly what our students need to catch up. Furthermore, the additional staff also allows OCS to cohort our students to maintain the safest environment possible.

The data that is used to identify our students' needs is through NWEA MAP testing. We are then able to pinpoint what each individual student needs support with and are then able to place them into the appropriate intervention class. Their progress will be monitored by administering the NWEA MAP assessment three times a year as well as using the assessments our intervention program provides, also three times a year.

Opportunity Charter School will be utilizing the Partnerships in Education and Resilience assessment to collect data on our students' social, emotional and mental health. We will be using this assessment to also monitor our student growth and/or progress in their individual needs. It will be given three times a year to give us three touch points of data for our students. This assessment is tied to a program that will give our social workers intervention suggestions for their students based on the data that has been collected for the students. Additionally, once a week our students participate in an advisory class where our teachers and social workers are trained in the Youth Communication curriculum that addresses our students social, emotional and mental health needs.

5. Opportunity Charter School has contracted with an in-person after school program for both middle and high school students that will be offering tutoring in Math and ELA every day. Tutors are experienced teachers who have Master's Degrees in their content area and are matched to students' strengths and areas of growth, which are determined by benchmark assessments that are administered multiple times a year. They also provide enrichment activities to engage students in interests that establish a pathway to college or develop skills of the future. Part of what our after school teachers use for their remediation is the continued use of our evidence-based intervention program that is used during the school day. The data provided to us by the Houghton Mifflin Harcourt is that prolonged use of these programs will improve our students' decoding, comprehension and math literacy skills.

Opportunity Charter School will spend its remaining ARP ESSER Funds to:

- Conduct weekly Covid-19 testing of 25% of staff and students in order to safely return students to in-person instruction;
- Purchase of materials and equipment to safely operate the school and meet the needs of students.
- Hire additional teaching staff and maintain existing teaching positions to maximize in-person instruction time;
- Lease additional space in order to adhere to guidance from NYCDOH, CDC and NYCDOE for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators and other staff;

A large majority of our students come from low-income families, are children with disabilities and are students of color. With regards to our students' social-emotional and mental health needs we assess students three times a year using the Partnerships in Education and Resilience assessment to determine their progress and to inform if any changes to the school's approach should take place. When their needs have been assessed we use an SEL curriculum in a weekly advisory class to support them in their growth. Additionally, each grade has a dedicated social worker and the social workers are also in the advisory classes to provide added social-emotional support. The after school program is used to address any academic deficits. We use the data we have collected from our benchmark assessments to determine who would benefit the most from Math or ELA tutoring. We are then able to monitor each students' progress from tutoring through both formative and summative assessments.
